RESOLVED: That the Town Board of the Town of Greenport adopts the following Fee Schedule for Greenport Water District No. 1:

A. PROCESSING FEE

RESIDENTIAL SERVICE ... (3/4" or 1")	\$500.00
COMMERICAL SERVICE... (1" or Larger)	\$500.00/inch of water service
OUT OF DISTRICT USER	\$1,500.00/inch of water service

D. FINANCE CHARGES.

All water bills that remain unpaid 45 days past the payment due date as written on the water bill shall be assessed a one-time 10% finance charge per billing period (6 months). Thereafter, those bills that remain unpaid at the conclusion of the next billing cycle shall be submitted to the County for relevy.

ANNUAL AVAILABILITY AND USAGE OF SPRINKLER SYSTEM BASED ON SIZE OF PROPERTY (SQUARE FEET)	
Minimum fee	\$200.00
10,000 square feet and above	Additional charge of \$0.005 per square foot above 10,000 square feet

WATER BILLS FOR THE ABOVE FEES SHALL BE MAILED TO THE PROPERTY OWNER AS STATED ON THE MOST RECENT TAX ROLL. IN THE EVENT OF NONPAYMENT, SAID UNPAID FEES SHALL BECOME A LIEN AGAINST THE REAL PROPERTY.

BE IT FURTHER RESOLVED THAT, the Town Board reserves the right to assess any additional fees not outlined herein on a case-by-case basis to ensure that the Town regulations are met.


