Resolution No. 70

**A Resolution Approving an Increase in Water Meter Fees
Pursuant to Section 118-12 of the Town Code.**

December 6, 2023

WHEREAS, the Town Water Superintendent has informed the Town Board of the Town of Greenport ("Town Board") of increases related to the cost of water meters and ancillary parts; and

WHEREAS, the Town Board is authorized to establish fees in relation to the cost and expenses related to the installation and connection of water service to the Town of Greenport water system pursuant to Article III, Section 118-12 of the Town Code; and

WHEREAS, the Town has received revised rates from its vendor and desires to increase such rates in accordance with the quote received.

NOW THEREFORE, BE IT RESOLVED, that the Town Board hereby adopts the following proposed rates starting on January 1, 2024:

5/8" x 3/4" residential meter	\$250.00
5/8" x 3/4" pit meter	\$290.00
3/4" meter	\$300.00
1" meter	\$400.00
1" residential pit (meter placed inside)	\$390.00
1 1/2" meter	\$790.00
2" compound meter with strainer	\$2,700.00
3" compound meter with strainer	\$4,000.00
4" compound meter with strainer	\$5,300.00
6" compound meter with strainer	\$9,000.00
5/8" x 3/4" pit (meter placed inside) with lid	\$1,100.00
1" pit (meter placed inside) with lid	\$1,400.00

BE IT FURTHER RESOLVED, this resolution shall supercede Resolution #51-2018 and any prior established water meter fees; and

BE IT FURTHER RESOLVED, this resolution shall be published with the Town Clerk within five (5) days.
